



# Overview

In 2021, the Buffalo Sewer Authority secured a \$55 million Environmental Impact Bond to finance the Rain Check 2.0 Program. The terms of the bond stipulate the management of 200 acres of impervious cover on public property within priority combined sewer overflow areas identified in the Rain Check 2.0 Opportunity Report, utilizing green infrastructure. The first optional redemption date is June 15, 2028, with interest rates increasing annually thereafter.





Project Description: Installation of green infrastructure practices at two Buffalo Municipal Housing Authority sites (Ferry Grider and Langfield/Kenfield) including underground storage within parking areas, stormwater tree trenches along the public right-of-way, and the planting of additional trees. Site improvements will also include the replacement of existing, disturbed features in kind, including curb ramps, curbing, sidewalk, and disturbed vegetated areas.
